

KITTEN / CAT PURCHASE CONTRACT

WE AGREE TO THE FOLLOWING:

Buyer agrees to provide this cat/kitten with a good and loving home. He/she will be kept up to date on all vaccines and buyer will make sure that all medical attention and treatment is given if necessary. He/she will never go outdoors unless accompanied by a human or protectively restrained. It will never be allowed to roam freely. Buyer agrees to provide companionship, exercise, toys, and never to leave the animal caged or alone for long periods of time. Females shall not be bred until at least one year old, unless there have been two heat cycles or medical indications. Females shall not be bred unless they are in optimum breeding condition

Kitten or cat shall never be sold, leased, or given to any animal shelter, cat wholesaler, retailer, research facility, or donated for any purpose. This includes pet stores, and raffles. Ownership, and all rights of such ownership, of animal, reverts automatically to seller, without compensation, or refund of any kind, to buyer, in any such instance. Buyer will be responsible for all costs associated with the return of animal to seller.

Buyer agrees to never have this animal vaccinated for FIP.

The seller's return-for-replacement guarantee, is for two days, for health reasons, provided that the kitten as been housed separate from other pets, and in a clean and safe environment. During this time, the buyer is urged to have his/her veterinarian examine the kitten thoroughly, at Buyer's expense, for health, structural normalcy, etc. The buyer is welcome to have it x-rayed or blood tested during the guarantee period. If the licensed veterinarian finds this cat to not be healthy, he or she must provide a written, signed statement to the seller, explaining the findings. The kitten may be returned, once the signed statement from the licensed Veterinarian is received by the seller. The kitten is to remain in quarantine until it is returned. The seller assumes no responsibility after that 48 hour period, as the seller has no control over its treatment, how it is fed, exposed to germs, etc. We suggest that you take a towel with you to the vet office to cover the examining table, and make sure that neither the vet nor his assistants handle the kitten without thoroughly washing their hands. Do not allow other animals, children, staff, etc., to touch your kitten in the waiting room. The seller is not responsible for any vet bills after the kitten leaves the seller's home.

The seller gives replacement warranty for death caused by congenital defects, for a period not to exceed one year. An autopsy report from a licensed veterinarian must be provided to the seller.

There are no cash refunds.

Seller does not guarantee any show wins on any animal.

Seller guarantees the fertility of any male sold as a breeder. If by age 2 years old, he has not gotten any Queen pregnant after trying him with at least three proven girls, he will be replaced with a male of equal value when available. Seller may require fertility testing to be done at the expense of the buyer. Male will be neutered and returned to buyer if buyer desires.

All kittens sold as pets will be spayed/neutered before they leave our home. A deposit of \$100.00 will be required to cover the cost of the spay/neuter. Deposits are nonrefundable.

This contract is legal and binding. If it is found that the buyer is not abiding by the conditions set above, the cat/kitten(s) will be returned to the seller at the buyers expense, without a refund. A sum of \$2500.00 for breach of contract will be given to the seller, over and above the original price, each and every time the contract is breached. The buyer is responsible for any and all legal fees.

Purchase price does not include shipping costs

This kitten is purchased for pet only, without breeding rights. Buyer agrees to alter this kitten/cat after four months, and before it reaches nine months of age. _____
